

Dear Town of Dale Property Owners:

Happy Holidays! You will be receiving your 2009 tax bills in the next couple of days. This letter is to inform you on how to and when to pay your taxes and dog licenses. We will handle tax collection as follows:

- 1) The First State Bank in **Dale** will once again accept tax payments. Please take your tax statement and check (made out for the **exact amount** of the first installment or the **exact amount** of full payment) made payable to the **TOWN OF DALE** to First State Bank in Dale during regular business hours:  
Monday, Tuesday, Wednesday and Thurs. 8:00 a.m. to 5:00 p.m. Friday 8:00 a.m. to 6:00 p.m.  
Saturday 8:00 a.m. to 12:00 p.m.  
**NOTE:** First State Bank in Dale and Wolf River Community Savings Bank cannot accept payments for amounts other than what appears on your tax statement and cannot accept payments for dog licenses. **Please do not use the drive-thru.**
- 2) Wolf River Community Savings Bank in Hortonville will also accept payments. You will need your tax statement and a check made out to **TOWN OF DALE** for the **exact amount**. Their regular business hours are as follows:  
Monday-Thursday 8:30 a.m. to 4:30 p.m.  
Friday 8:30 a.m. to 5:00 p.m. Saturday 8:30 a.m. to noon
- 3) You can mail your tax statements and check or money order to Erica Siewert, Town of Dale, P.O. Box 83, Dale, WI 54931. To receive a receipt for your tax payment, you must include a **stamped, self-addressed envelope**. The town has a drop box located in front of the Municipal Building where tax payments and dog licenses may also be placed.
- 4) Taxes will be collected at the Dale Municipal Building on the following dates. Please bring your tax statements and payments in the form of checks or money orders (**no cash**).

5) There is one more way to pay your taxes. You can go online with a credit card or electronic check at [www.witreasurers.org](http://www.witreasurers.org) , [www.co.outagamie.wi.us](http://www.co.outagamie.wi.us) (depts.-treasurer/tax listing), [www.townofdale.org](http://www.townofdale.org) or by phone at 1-800-272-9829. You must choose property tax payment option #3 and then follow the steps: 1) Enter jurisdiction code 5968 2) Press 1 to pay property tax 3) Enter payment information 4) Enter credit card information. Keep confirmation number with your records. There is a 2.75% fee for credit card payments and \$2.75 fee for electronic check payments charged by the Official Payments Corp. The fee is \$15.00 for payments over \$10,000.

In case of inclement weather on any of these scheduled dates please call ahead. You can call the hall at 779-4609, Erica Siewert at 779-0429 or Marcia Kelly at 779-6769. To help clear up some confusion, the tax bills for the Town of Dale are generated by Outagamie County. If information on your tax bill is not correct (including your address), please contact the County Treasurer's Office at 832-5065. Any questions regarding your local tax rate and special assessments should be directed to your town board. The first installment is due January 31 and is payable to the **Town Treasurer**. Your town treasurer **cannot** accept any tax payments after January 31. The second installment is due July 31 and is payable to the **Outagamie County Treasurer**. Please refer to your tax statement for the address.

#### **LOTTERY CREDIT**

This year's tax bill will include a lottery credit for each house lived in on January 1, 2009. The credits amount to \$70.29 for those in the Hortonville School District and \$77.56 for those in the New London School District.

## GARBAGE COLLECTION

Graichen Sanitation is the Town's garbage collector. If you have problems with your garbage pickup, please call them at 982-4116 or call the Town Hall at 779-4609. The special assessment for garbage is \$ 142.00 this year. This has gone up because of the cost of gas, etc. for the garbage company which forced them to raise our contract price and also because of the rising cost of recycling. There are extra recycling stickers available at the Town Hall. The town's recycables are picked up by Inland Refuse. Remember to place them in plastic garbage cans with a recycling sticker on it. Please do not use plastic bags. If you have any concerns, please call them directly at 759-0501. Any other recycling questions can be answered by Outagamie County at 832-4710. Remember that Christmas wrapping paper is not recyclable.

### Special Charges On Your Tax Bill

1. Most residents will have a new charge on their tax bills called a POWTS fee. This is in regards to septic tanks and will show up as a \$12.00 fee from Outagamie County.
2. Some residents will have charges for delinquent sewer payments.
3. Some residents will have a misc. charge for street lights.

## DOG OWNERS

Dog licenses are required for all dogs age five months and older. You are required to obtain the license by **March 31**. You must present proof of rabies vaccination (available from your veterinarian) when purchasing the license along with the proper fee. The fees for licenses are **\$5.00** for spayed or neutered dogs, and **\$10.00** for unspayed or unneutered dogs. Please write a separate check for dog licenses payable to the Town of Dale. Mail the proof of rabies vaccination, check, and stamped self-addressed envelope to Erica Siewert, Town of Dale, P.O. Box 83, Dale, WI 54931. If your dog was licensed during 2006, all the necessary information is on file. You will be required to provide a *rabies* vaccination certificate **ONLY** if your dog's rabies vaccination expired since last licensing date or if you are licensing your dog for the first time.
