

**TOWN OF DALE TOWN BOARD MEETING  
MARCH 10, 2009**

Chairperson Wunderlich called the meeting to order with two board members, treasurer, clerk, Attorney Forsgren, and 10 residents present.

Chairperson Wunderlich motioned, seconded by Supervisor Kloehn, to approve the Certified Survey Map for Donald Kuettel.

The Town applied on February 18, 2009 for a stimulus grant for lighting, landscaping and ball diamond fence in Daufen Park. To date, the Town has not heard if the grant has been awarded.

Deb Calmes has agreed to run the Farm Market. It will be held on Fridays from 4 to 7 p.m. June to Oct. at the Dale Municipal Building.

The Planning Commission reviewed the Certified Survey Map for Donald Kuettel and approved it subject to the corrections suggested by Martenson & Eisele Engineering firm. The Planning Commission is reviewing the Comprehensive Plan for updates. The next meeting will be held on April 7, 2009 at 7:30. The following members will continue for another term:

Chief Emmons reported 11 calls for January. Five First Responder, two accidents, one smoke in basement, one structure fire, one mutual aid Greenville, and one mutual aid New London.

Building Inspector Emmons reported 1 permit for the month of December.

Attorney Forsgren reported that he continues to work on a Storm Water Ordinance. He also will draft a renewal contract with Caledonia for Fire Service. The contract is up for renewal in 2010.
